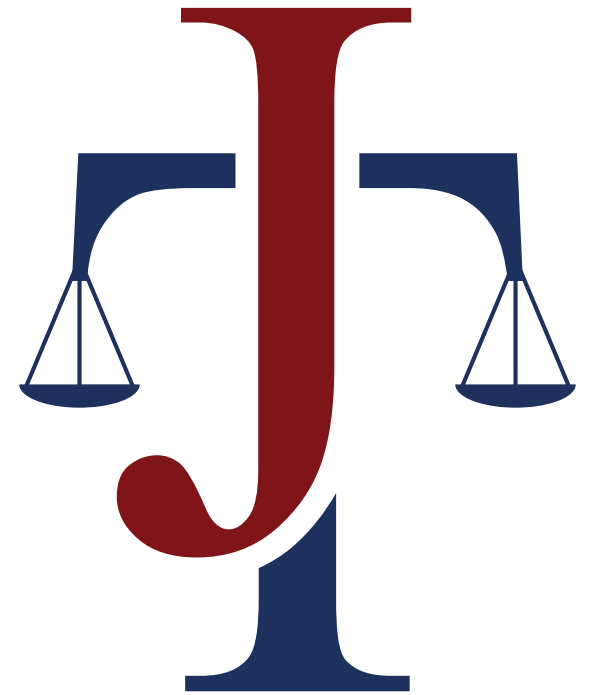

These are some of the most common types of accidents. When someone you rely on for your safety neglects their duties and causes you harm or injury, they are responsible to make things right for your health and well-being.

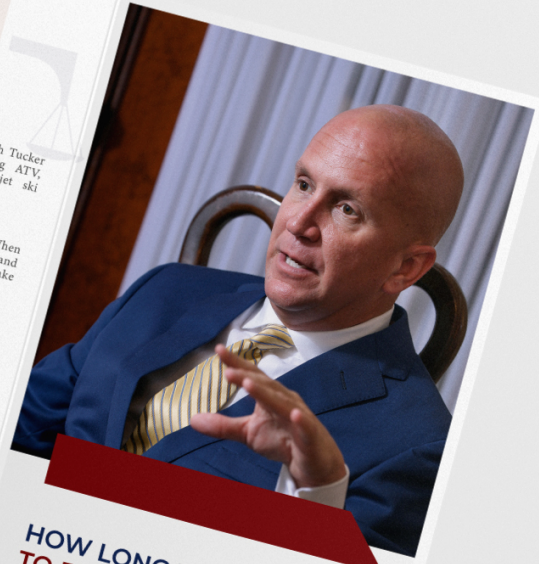
Dog & Animal Bites and Injuries
